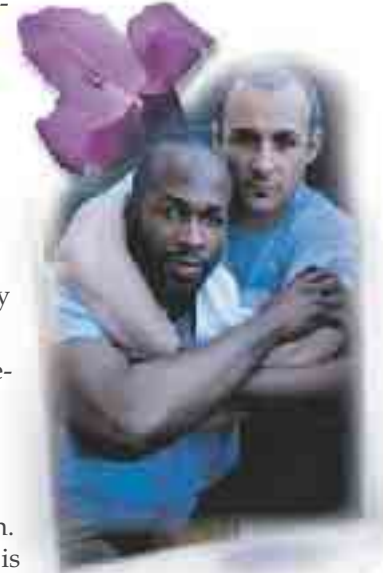

DPMA™ is the most powerful legal contract that couples can use to obtain the rights of marriage. It is a set of documents that implant the contractual legal rights and responsibilities of each partner in your committed long-term relationship and has a recognized legal structure. With it, you can conduct yourselves like a married couple. DPMA™ covers a broad range of rights and is not limited to any one state.

Your DPMA™ creates joint ownership of assets and addresses the most important and complex issues that you deal with today when planning your future. Assets placed within the DPMA™ are owned by the partnership and are addressed in detail.

DPMA™ clauses allow you to:

1. Deal with your business interests and activities as a couple.
2. Execute contractual agreements, borrow money, and pay debts and expenses as a couple.
3. Open joint bank accounts as a couple.
4. Prohibit distribution or liquidation of assets without the consent of your partner.
5. Open to membership of additional members, i.e. addition of a minor, child, or another family member is permitted.
6. Income tax advantages. Tax benefits are passed through to individual's federal income tax return with Form 1040.
7. Bankruptcy or insolvency of one or both partners does not affect assets of the DPMA™.
8. Estate planning.
 - ✓ Your DPMA™ assets can be shared between you and your partner at your discretion. Designate whether a particular piece of property (real, personal, gift or inheritance) is owned jointly or belongs solely to one partner.
 - ✓ Should something happen to one of you, only the surviving partner receives the assets. No one else can acquire the assets, not even your relatives (unless designated).
 - ✓ In the unlikely event that something happens to both partners, the assets of your DPMA™ will be distributed to pre-designated beneficiaries.
 - ✓ May help avoid estate taxes and probate court.
 - ✓ Death of either partner does not dissolve the DPMA™.

DPMA™ is best suited for couples that own or plan to buy property (ie. house, car, boat, 401K, or bank account) that they wish to keep for their partner. In many cases, properties such as houses and cars have gone to relatives, not partners, because same-sex couples are not protected. If you want to protect and control your assets, DPMA™ is your most powerful ally. Some couples mistakenly create joint bank accounts, purchase a home together, name each other as beneficiaries of their 401Ks, and make other joint decisions as an expression of their commitment to each other and their future together. However, many find out the disastrous legal and tax consequences too late.

A married couple's assets are not subject to estate taxes until both spouses have died. But, same-sex couples don't have an "unlimited marital tax deduction," and could end up with double taxation of the same assets. Often, the grieving partner must have an unpleasant fire sale to satisfy the IRS and even be forced to liquidate assets to satisfy claims from relatives. In many ways, DPMA™ is even more powerful than a marriage certificate.
